Missed Lesson/Make-up Policy - please review - thank you!

Class space is held, our horses and staff are here ready for your/your rider's attendance! Notice must be given at least 24hrs in advance of a missed lesson to be eligible for a make-up practice ride. Missed lessons are made up as independent practice rides held Saturdays at 1:00 - 2:00 p.m. Beginner A/A+ students not ready for practice rides: if no make-up lesson is available, we will roll over credit to the next quarter for a maximum of two missed lessons per quarter. Lessons may be canceled or combined at management's discretion - riders unable to attend a rescheduled lesson are eligible for the above make-up policy.

Weekly Lessons - Ages 6 and Up☐ **12 Lessons** - \$500/3-month Quarter; **7 Riders/lesson** (max 6 students in regular Beginner A/A+)

- Most lessons will be one hour. One lesson may be unmounted to teach horsemanship, tacking, grooming, etc. at the instructor's discretion.
- Beginner A/A+ lessons will be a 45-minutes and held in the indoor arena. These lessons will be limited to no more than 6 riders for 45 minutes of instruction, 5-10 minutes for mounting and adjusting tack. One of 12 lessons may be unmounted and will cover proper grooming, leading, and tacking of a horse/pony.

Lessons + Winter RideShare Leasing - must be over age 10 + instructor approval

- Winter Quarter leasing is 12 weeks from November 29th to February 19th
- **Leasers may not jump during regular lease rides - ground poles only!**
 - **Supervised jump rides may be purchased for an additional \$5/ride, scheduled on Fridays between 3 - 5PM or Sundays between 9 - 11AM**
- URC must utilize horses as needed for our various programs; the lesson program has priority over horses at all times. ***While a lease horse cannot be guaranteed available for all lease rides or lessons, students will always have the option of riding a different horse appropriate for their level!***
 - Text to the business line (240)877-4686 to confirm each lease ride 24hrs in advance is helpful for our planning!
 - Riders check the lesson board to see if your lease horse is available before beginning a ride. Horses may not be used within 1.5 hours of a lesson. We try to post lease rides along with the lesson lists.
- **Expect horses to be outside from 8am to 4pm daily - leasers may need to catch their horse from the field!** We do not leave horses inside for lease rides.
- Lease rides can be scheduled between 9am - 8pm daily
- Riders must participate in 12 lessons at URC before they are eligible for the RideShare Program
- Typically, riders must be above the "Beginner C" level to be approved for leasing
- School horses may have more than one lessor, at management's discretion.
- **Missed lease rides are not eligible for 'make up' or roll-over to another week or quarter**

RideShare Leasing Agreement for Quarterly Program: *I understand this is an unsupervised ride program and will accept all the risks of a rider as if this were my/my child's own horse.*

Any child under the age of 13 must be accompanied by an adult guardian at all times and no one is permitted to ride without another person present in/around the rings/trails/barns.

Riding should be limited to 45 minutes total and include proper warm up and cool out.

Students are not permitted to jump unless participating in the supervised jump/lease ride days and times listed above.

Leasers may not trade horses, or allow any other student, leaser, or boarder on 'their' horse during the scheduled lease ride. All school tack should be put back after use on the appropriate racks, neatly.

All other leasing rules listed on the website apply. URC reserves the right to remove a student from the RideShare program, for any reason, without warning or refund. I/we will any report injury or illness exhibited by the horse immediately. I/we understand there is no riding off URC property for any reason, no riding in barn aisles.

Warning protocol: If the posted RideShare rules are violated; URC staff will issue a verbal warning. After the verbal warning, a second offense will result in a written warning, issued via text/email. After the initial written warning, a violation of RideShare rules will result in a final written warning via email. After the third and final warning, a violation of RideShare Rules will result in the student's immediate removal from the RideShare Program with no refund.
