Missed Lesson/Make-up Policy

Class space is held; our horses and staff are here anticipating you/your child's attendance - notice must be given at least 24hrs in advance of a missed lesson to be eligible for a make-up practice ride. Missed lessons are made up as independent practice rides on Saturdays with the exception of Beginner A/A+ students. Beginner A/A+ lesson do not have a make-up option- we will roll over credit to the next quarter for a maximum of two missed lessons per quarter.

- Lessons may be canceled or combined at management's discretion.

Weekly Lessons - Ages 6 and Up

☐ **12 Lessons** - \$500 3-month Quarter; **7 Riders/lesson** (max 6 at Beginner A/A+)

- Most lessons will be one hour. One lesson may be unmounted to teach horsemanship, tacking, grooming, etc. at the instructor's discretion.
- Beginner A/A+ lessons will now be a 45-minutes and held in the indoor arena. These lessons will be limited to no more than 6 riders for 45 minutes of instruction, 5 minutes for mounting. One of the 12 lessons may be unmounted and will cover proper grooming, leading, and tacking of a horse/pony.

Lessons + Summer RideShare Leasing - must be over age 10 + instructor approval

Please read the following as changes have been made!

- During the summer quarter we will only offer leasing for 3 WEEKS from June 1st to June 20th
- URC has the right to utilize horses as needed for our various programs; the lesson program has priority over the horses at all times. **A lease horse is not guaranteed to be available for lease rides or lessons, but students will always have the option of riding a different horse appropriate for their level.** Students must check the lesson board to see if the lease horse is available before beginning their ride. Horses may not be used within 1.5 hours of a lesson.
- Expect horses to be outside from 3pm to 9am daily - leasers should be prepared to catch their horse from the field! We cannot leave horses inside for lease rides.
- Students must participate in 12 lessons before they are eligible for the RideShare Program
- Typically, Students must be above the "Beginner C" level to be approved.
- Each school horse may have more than one leaser, at management's discretion.

RideShare Leasing Agreement for Quarterly Program: I understand this is an unsupervised ride program and will accept all the risks of a rider as if this were my/my child's own horse. **Any child under the age of 13 must be accompanied by an adult guardian at all times** and no one is permitted to ride without another person present in/around the rings/trails/barns. **Riding should be limited to 45 minutes total** and include proper warm up and cool out. Students are not permitted to jump higher than their lesson level and no leaser is allowed to jump over 2'6". Leasers may not trade horses, or allow any other student, leaser, or boarder on 'their' horse during the scheduled lease ride. All school tack should be put back after use on the appropriate racks, neatly. All other leasing rules listed on the website apply. URC reserves the right to remove a student from the RideShare program, for any reason, without warning or refund. I/we will any report injury or illness exhibited by the horse immediately. I/we understand there is no riding off URC property for any reason, no riding in barn aisles.

Warning protocol: If the posted RideShare rules are violated; URC staff will issue a verbal warning. After the verbal warning, a second offense will result in a written warning, issued via text/email. After the initial written warning, a violation of RideShare rules will result in a final written warning via email. After the third and final warning, a violation of RideShare Rules will result in the student's immediate removal from the RideShare Program with no refund.
